Smt.Dhanya.M.A, wife of late V.U.Kuttan,Plumber, Water Works Section No.I, Thrissur has submitted an application for employment assistance under Compassionate Employment Scheme. The application had been placed before the 381st Kerala Water Authority Board meeting and the Authority vide Resolution No.10220 resolved to recommend to the Government for considering the application of Smt.Dhanya.M.A, wife of late V.U.Kuttan, Plumber, Water Works Section No.I, Thrissur Division under compassionate employment scheme.The application had been submitted to the Government along with the verification report of the District Collector concerned. Now the Government of Kerala vide order read third above accorded sanction for appointing her as Lower Division Clerk based on the qualification possessed by the applicant.

In this circumstance the applicant Smt. Smt.Dhanya.M.A, wife of late V.U.Kuttan, Plumber, Water Works Section No.I, Thrissur is provisionally appointed as Lower Division Clerk in the scale of Rs.20100-53300 under Compassionate Employment Scheme and posted at P.H.Sub



Division Irinjalakkuda in the existing vacancy.

The appointee shall join duty within 15 days on receipt of this order failing which the appointment will be liable to be cancelled without further notice. The date of joining/non joining duty shall be reported to this office along with the filled up proforma.

The appointee shall be on probation for period of 2 years on duty within a continuous period of 3 years. The appointee shall produce the following original documents at the time of joining duty.

- 1.Certificate to prove the age and qualifications.
- 2.The certificate of physical fitness issued by a Medical Officer not below the rank of a Civil surgeon.
- 3.Enclosed proforma as per G.O(P)No.79/2009 dated 05/06/2009(published in KWA website) duly filled up.
- 4.Passport size photograph duly attested by a Gazetted Officer.
- 5.ID proof

The employment assistance ordered under the scheme will be cancelled if and when Government find out there was any suppression or misrepresentation of any material facts on the part of the applicant at the time of forwarding the application or during the course of enquiry conducted by Kerala Water Authority.

The candidate is also informed that Kerala Water Authority has decided to make applicable Government Orders regarding the new pension scheme in Kerala Water Authority with effect from 01/04/2013 which shall be applicable to all appointment made thereafter.
