They will be on probation for a period of 2 years duty within a continuous period of 3 years of service in this organization. The candidates will have to join duty within 15 days from the date of receipt of this order, before the controlling officers concerned with the documents in original to prove date of birth, qualifications, community etc and a physical fitness certificate obtained from a medical officer not below the rank of a Civil Surgeon (in the Medical Certificate there should be the photograph of the candidate and finger print duly attested by the Medical Officer as prescribed in the Government Order read 4th above). The candidate should produce the proforma as per G.O.(P)No.79/2009 Home dated, 05.06.2009 (which is published in the official website of Kerala Water Authority) duly filled up and signed at the time of their joining duty in this organization. If they fail to join duty within the stipulated time their appointment in the cadre of Meter Reader in this organization will be treated as cancelled without any further notice to the candidates.

The candidates are also informed that in the event of discharge from service for want of vacancies, they may either re-register their names in the office of the Public Service Commission/District Office of

Kerala Public Service Commission from where they were advised and get themselves re-appointed in further advice by the Kerala Public Service Commission or they may wait for their turn for re-appointment to the post in the Department, in case they desire to continue as probationers in the post from which they were discharged.

The Controlling Officers may admit the candidates only after verifying the particulars regarding Name, address, date of birth, community, qualifications etc, given in the Kerala Public Service Commission advice letter (extract enclosed) with documents in original.

The Non Creamy Layer certificate of the candidates advised in BC turn should be verified before admitting the candidate for duty.

Service Book of the incumbents shall be opened within one week from the date of joining duty. The appointment shall be regularized only after obtaining verification report from the Police authorities and Kerala Public Service Commission. For this purpose Head of Office will forward attested copies of the pages of Service Book containing Name, address, personal identification marks, Thumb impression, signature, date of joining duty, (ie., Service Book pages 1, 2, 3, 4, 15 and 16) details of previous service if any and copy of identification certificate pasted in the Service Book of the incumbents as stipulated in the Government Order read as 4th above along with the filled up proforma submitted by the incumbents at the time of their joining duty to this office.

The date of joining duty shall be reported to this office along with the filled up proforma submitted by the incumbent at the time of joining duty in case of non joining duty identification certificate will be returned to this office.

Application for correction of date of birth, if any, shall be made within 5 years from the date of entry in service.

The new pension scheme introduced vide reference 5th cited will be applicable to the incumbents.
